Gotham Shuttle HIPPA-Compliant Service Agreement

Obligations and Activities of Gotham Shuttle Service

Gotham Shuttle Service agrees to:

(a) Not use or disclose protected health information other than as permitted or required by the Agreement or as required by law;
(b) Use appropriate safeguards, and comply with Subpart C of 45 CFR Part 164 with respect to electronic protected health information, to prevent use or disclosure of protected health information other than as provided for by the Agreement;
(c) Report to any use or disclosure of protected health information not provided for by the Agreement of which it becomes aware, including breaches of unsecured protected health information as required at 45 CFR 164.410, and any security incident of which it becomes aware;
(d) In accordance with 45 CFR 164.502(e)(1)(ii) and 164.308(b)(2), if applicable, ensure that any subcontractors that create, receive, maintain, or transmit protected health information on behalf of Gotham Shuttle Service agree to the same restrictions, conditions, and requirements that apply to Gotham Shuttle Service with respect to such information;
(e) Make available protected health information in a designated record set to "" as necessary to satisfy 's obligations under 45 CFR 164.524;
(f) Make any amendment(s) to protected health information in a designated record set as directed or
